





NOTICE OF RACE 2019 210 ASSOCIATION NEW ENGLAND CHAMPIONSHIP'S AT THE CPYC REGATTA TO BENEFIT MAKE-A-WISH AUGUST 3 & AUGUST 4, 2019

1. ORGANIZING AUTHORITY The Organizing Authority (OA) is the Cottage Park Yacht Club in conjunction with the International 210 Association.

RULES

- **3.1.** The Cottage Park Yacht Club Regatta to Benefit Make-A-Wish will be governed by the *rules* as defined in the *Racing Rules of Sailing*, 2017 2020.
- **3.2.** The class rules of the of the 210 Association will apply.
- **3.3.** By participating in this regatta, a competitor grants to the organizing authority and its sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any photographs, motion pictures and live, taped or filmed television and other reproductions of him or her during the period of the competition without compensation.
- **3.4.** Each competitor will be responsible for his or her boat being in compliance with the class rules. The class rules will be used, except that RRS 60.1(a) is changed to prohibit a boat from protesting another boat for an alleged breach of a class rule requiring class membership or imposing a weight limit.
- **3.5.** Competitors shall bring their own boats, and tow boat, etc.
- **3.6.** Advertising Competitors will comply with ISAF Regulation 20.
- **3.7.** Sail numbers All boats must have a unique sail number that MUST match their entry on their registration form.
- 4. **ELIGIBILITY** The regatta is open only to boats meeting the requirements of the International 210 Class.
- **5. NOTICE TO COMPETITORS –** Notice to Competitors will be posted on the Official Notice Board located in the ballroom of CPYC. They will also be posted www.regattaman.com

6. FEES AND REGISTRATION

- **3.1** Entry Fee of \$75 (includes one dinner ticket.) Boats registering after registering after Aug 2 are requested to make a \$25 donation.

- 10.1 Marks of the course shall be inflatable drop marks and/or government marks. CPYC Harbor race marks charts will be provided.
- 10.2 The courses will be Windward/Leeward or Triangle courses.
- 11. SCORING The Low-Point Scoring System, Appendix A of the RRS will apply. Three (3) races are scheduled. One (1) race qualifies as a series
- 12. PRIZES Prizes will be awarded according to the International 210 Association tradition. Make-A-Wish trophies will be awarded to competitors placing first through third in all divisions.
- 13. DISCLAIMER Competitors participate in the regatta entirely at their own risk. See RRS4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

- **14.2** Each boat must carry insurance with liability coverage of at least \$300,000.
