
### 29TH ANNUAL REGATTA YOUTH SAILORS NOTICE OF RACE AUGUST 5TH, AND 6TH 2023

#### 1. RULES

- 1.1. The Cottage Park Yacht Club Regatta to Benefit Make-A-Wish will be governed by the rules as defined in the Racing Rules of Sailing, 2021 - 2024.
- 1.2. The rules of the Club 420, Fevas, Optimist, Laser and N-10 classes will apply.
- 1.3. By participating in this regatta, a competitor grants to the organizing authority and its sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any photographs, motion pictures and live, taped or filmed television and other reproductions of him or her during the period of the competition without compensation.
- **1.4.** Competitors shall bring their own boats, dollies and tow boat and tow line. .
- **1.5** Each competitor will be responsible for his or her boat being in compliance with the class rules. The class rules will be used, except that RRS 60.1(a) is changed to prohibit a boat from protesting another boat for an alleged breach of a class rule requiring class membership or imposing a weight limit.
- 1.6 Each competitor will be responsible for his or her boat being in compliance with the class rules. #### 2. DISCIPLINE

- 2.1 Per US SAILING Regulation 5.03 no contestant shall use, either on or off the water, during any US SAILING sanctioned event: marijuana or any other controlled substance (as defined in 21 U.S. Code 802) the possession of which is unlawful under 21 U.S. Code 841, or alcoholic beverages (distilled spirits, wine and beer, each as defined in chapter 51 of the U.S. IRC Code and intended for beverage use). This regulation is in effect from date and time of arrival through date and time of departure from the locale. The penalty shall be that the contestant after a proper hearing, be immediately removed from the regatta venue and, where practical, sent home.
- **2.2** All competitors are expected to maintain the highest level of conduct throughout the entire event. When the Protest Committee, from its own observation or a report received from any competitor that believes that another competitor may have committed a breach of a rule, good manners, or sportsmanship, or may have brought the sport into disrepute, it may call a hearing. After a proper hearing the penalty may range from a reprimand to dismissal from the regatta and additional action may be taken under RRS 69.
- **2.3** Hearings will be held generally in accordance with the recommendations of Appendix M5 of the RRS. The officers for hearing a violation will consist of the Chief Judge, acting as chairman of the hearing, and the Protest Committee.
- 3. ELIGIBILITY. Eligible classes are: Club 420, Fevas, Optimist, and N-10 classes
  - 3.1 Optimists (Green and Champ Fleet,), Club 420's (Championship White and Green Fleets), Fevas,

and N-10 (Championship-White and Green Fleets) will be sailed. Five boats shall constitute a class, subject to revision at the organizer's discretion.

- **3.2.** 420 Green Fleet is a beginner racing division, first year racing a 420 with limited races last season. 420 Green is a non-spinnaker fleet. For Optimist Green, a skipper must not have previously won more than two first, second or third place trophies, must not have previously raced in the Red, White or Blue Fleets (unless no Green Fleet was available). The N-10 Green is a beginner racing division and no spinnakers may be flown. N-10's will be double handed, skipper and crew

- **5.1** Entry Fee of \$75 per sailor, (includes continental breakfast, Sat lunch, dinner and Pier parties.) Boats registering after registering after August 5th are requested to make a \$10 donation.

- 8. VENUE. All courses will be on the inside line, in Winthrop waters between Winthrop and Logan Airport.
- 9. COURSES Will be described at the skippers meeting.
- **10. SCORING –** The Low-Point Scoring System, Appendix A of the RRS will apply. As many races as possible will be scheduled, of which one shall be completed to constitute a series. If six or more races are sailed, a boat's worst score shall be discarded.

#### 11. SAFETY-

- 11.1 A US Coast Guard approved personal floatation devices shall be worn, properly fastened, at all times on the pier, launching, and sailing. Failure to comply with this rule can result in disqualification as deemed appropriate by the protest committee.
- 11.2 A boat retiring from a race shall notify Race Committee vessel before leaving the course, or when that is impossible, shall notify a regatta official immediately upon arrival ashore.
- 11.3 All coaches and support personnel on the water are strongly encouraged to wear PFD's.
- 11.4 Boats are required to check in at the Signal Boat before the first race, of the day.
- 12. PRIZES Make-A-Wish trophies will be awarded to competitors placing first through third in all divisions.
- **13. DISCLAIMER -** Competitors participate in the regatta entirely at their own risk. See RRS4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.
