



**CREW WAIVER OF LIABILITY**  
**For Sail For A Change, August 12-13, 2016**

I, the undersigned, intend to participate in **Flip Flop Regatta ("FFR")**, a charity sailing regatta organized by the **Boston Youth Sailing Foundation ("BYSF")**, and other related events sponsored or supported by **Courageous Sailing Center ("CSC")** and **BYSF**, and any other subsequent partner organizations.

For good and valuable consideration, including being permitted to participate in **FFR**, I, the undersigned, for myself, my successors, heirs and assigns hereby waive, release and discharge any claims, causes of action or any type of demand whatsoever that I may have now or in the future against **CSC, BYSF** and/or **FFR**, their respective officers, directors, agents, volunteers, or employees, for any bodily injury or death suffered by I, the undersigned, or for any damage to any boat or other property arising out of my involvement in **FFR** or training therefor, and any other related activities sponsored by **CSC, BYSF** and/or **FFR**, in connection with the conduct and organization of **FFR**. I am in good health and have no physical condition that would prevent me from participating in this event.

I, the undersigned, acknowledge that participation in the sport of sailing or in **FFR** involves substantial risk of personal injury or even death, and I, the undersigned, hereby assume the risk of any such injury or death arising while practicing for or participating in said **FFR**, and forever give up and relinquish any claim for liability against **CSC, BYSF** and/or **FFR**, their respective officers, directors, agents, volunteers, or employees, that I may have by reason of participating in and/or training for **FFR**.

I expressly agree that the foregoing release of claims, waiver and indemnity are intended to be as broad and inclusive as permitted by Massachusetts and any other relevant law and that if any portion thereof is held invalid, it is agreed that the remaining provisions shall notwithstanding continue in full force and legal effect.

I, the undersigned, as consideration for **CSC, BYSF** and/or **FFR's** permission for me to participate in the **FFR** and related activities and events, hereby agree to indemnify and hold harmless **CSC, BYSF** and/or **FFR** for any damage or other injury which I, my boat, or crew may

In consideration of this entry being accepted, I hereby for myself, heirs, executors, administrators, assigns and representatives, waive and release any and all right and claim for damages I may have against **CSC**, **BYSF** and/or **FFR**, the Massachusetts Department of Environmental Management, the Commonwealth of Massachusetts, The City of Boston, The Boston Parks & Recreation, their respective agents, representatives, successors and assigns for any and all injuries suffered by me at said event or while traveling to or returning from said event, save those proximately caused by the willful tortuous acts of the state, its agents, servants and its employees.

I grant permission to use my name and images for promotional materials produced during/for this event.

This document may have serious consequences in the event of any injury to I, the undersigned, and one should feel free to consult a lawyer concerning its implications before signing the release.

I hereby execute this Waiver of Liability, including the release of claims and indemnification provisions, for myself and my heirs, executors, assigns, and representatives. In signing this release, I acknowledge and represent that I have read the foregoing Waiver of Liability, understand it and sign it voluntarily; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by the same.
